

## ALFDC Small Home Raffle

Terms and Conditions (On-Reserve)

### 1. Organizer

The Small Home Raffle (“Raffle”) is organized by ALFDC, operating on Tyendinaga Mohawk Territory

### 2. Jurisdiction and Licence

- This Raffle is conducted on-reserve under the authority of the Mohawks of the Bay of Quinte.
- The Raffle is licensed under Licence No. **MBQ-26-R0001**, issued by the Mohawks of the Bay of Quinte, Tyendinaga Mohawk Territory.
- The Raffle is operated in accordance with applicable community laws, policies, and approvals.
- Provincial or federal gaming legislation applies only where required and does not supersede First Nation jurisdiction.

### 3. Eligibility

- Open to individuals 18 years of age or older at the time of ticket purchase.
- Open to on-reserve and off-reserve participants, unless otherwise stated.
- Employees, board members, and immediate family members of Circle Housing Corporation are not eligible.
- Void where prohibited.

### 4. Raffle Period

- Ticket sales start: May 1st, 2026
- Ticket sales end: September 25, 2026 at 11:00am, or when all tickets are sold.
- Draw date: September 25<sup>th</sup>, 2026, at 12:00pm, conducted on-reserve.

### 5. Tickets

- Ticket price: \$100 per ticket or 6 for \$500 **CASH ONLY**
- 1500 tickets are being SOLD
- Maximum No maximum tickets per person.
- All ticket purchases are final. No refunds or exchanges.
- Tickets must be purchased through authorized ALFDC sellers, front office, or LMI/Arms representatives

### 6. Prize

- One (1) Small Home 10x40
- Prize is awarded **“as is, where is.”**
- Prize does not include land, delivery, setup, foundation, utility hookups, permits, insurance, or any other expenses related to this prize
- Approximate value: \$75,000 CAD.

### 7. Winner Selection

- One (1) winner will be selected by random draw from all eligible tickets sold.
- Odds of winning depends on the number of tickets sold.

### 8. Winner Notification and Claim

- The selected winner will be contacted using the information provided at ticket purchase.
- The winner must respond within **15 days** to claim the prize. If after the **15 days** ALFDC reserves the right to draw another winner.
- The winner must provide valid photo identification.

### 9. Costs and Responsibilities

- Any costs related to accepting, transporting, placing, or maintaining the Small Home are the sole responsibility of the winner.
- ALFDC assumes no responsibility for zoning, bylaws, or land-use compliance on/ off-reserve.

### 10. Publicity

By accepting the prize, the winner agrees to the use of their name, community, image, and likeness by ALFDC for promotional purposes without additional compensation.

### 11. Limitation of Liability

ALFDC is not responsible for lost, delayed, or misdirected entries, technical errors, or any injury, loss, or damage arising from participation in the Raffle or use of the prize.

### 12. General

- ALFDC reserves the right to amend, suspend, or cancel the Raffle if required by community decision, law, or unforeseen circumstances.
- All decisions of the Organizer are final.
