In this role, you will:

- Build strong, respectful relationships with students, families, Elders, and Knowledge Keepers
- Organize cultural events, workshops, ceremonies, and land-based learning opportunities
- Support cultural competency education for staff, partners, and community members
- Develop and maintain cultural resources, materials, and program plans
- Promote language revitalization and integrate culture into school activities
- Manage program logistics including scheduling, travel, honorariums, and materials
- Foster a safe, inclusive, and culturally grounded environment aligned with MCFN values
